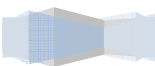
## The Information We Collect

6. Description of the situation you would like to receive guidance

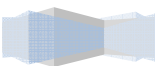
All credit card information is processed through our 3<sup>rd</sup> Party shopping cart, which is offered and managed through PayPal (<http://www.paypal.com>). All mailing list information is processed through our 3<sup>rd</sup> Party system, which is offered and managed through Constant Contact (<http://www.constantcontact.com>). ## **The Way We Use Information**

The information you provide about yourself when placing an order for a service or product (Life Coaching, workshops, retreats) is used by MeredithBromfield.com, AgapeFA.com, CrossingYourBridge.net or CrossingYourBridge.com only to complete that order. We use the e-mail address provided to reply to your request. Or, we use the phone number provided to reply to your request.

We use the description of the situation to create our analysis and advice and help us have an understanding of your needs so we can ensure you are happy with the services purchased. This information is NOT stored on any Web Servers. We don't disclose or share this information with any outside parties.

The information you provide about yourself when you pay online by credit card is used by MeredithBromfield.com, AgapeFA.com, CrossingYourBridge.net or CrossingYourBridge.com to confirm the transaction has processed. The information encrypted as it transfers to 1ShoppingCart.com for processing. Once the transaction is processed, this



information is destroyed; it's not stored. We do not disclose or share this information with any outside parties.

We use return email addresses to answer the emails we receive, to send confirmations of purchase, send products both purchased and received for free, to send newsletters and to send weekly Words of Wisdom (WOW). Such addresses aren't used for any other purpose and aren't disclosed or shared with outside parties. 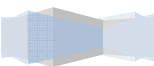
We never use the personally identifiable information provided to us online in ways unrelated to the ones described above.

## **Our Commitment to Children's Privacy**

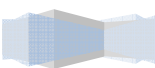
